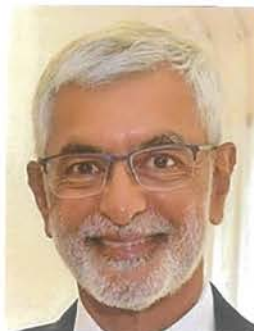

My name is Sam Sharpe, and I would like to stand for the position of Chairman of the Games Control Board.

I have now served on the General Committee for two years, including most recently as the chair of the Rules and Membership sub-committee. It's been an honour and a privilege to be able to help members with concerns and requests relating to membership matters as well as working to reform some of the Club's policies and procedures.

I am standing for the position of Chairman of the Games Control Board out of a desire to contribute to the development of sports at the club, particularly as we emerge from COVID restrictions and into, hopefully, a resumption of competitive play and associated events and social activities.

Sports has always been a very important part of what being a Club member means to me and much of the joy and benefit I get from being a member comes from our rich sporting culture. I have been an active member of the Rugby Section for over 12 years, and I have represented the club on the rugby field throughout this time and will continue to do so. I have also captained the SCC Tankards (2nd team), I was then Club Captain for the Rugby Section for two years and went on to be Convenor of the Rugby Section for another 3 years.

I have been the co-chair of the Singapore Cricket Club International Rugby Sevens for two years (2017 and 2018). I am also involved in managing the SCC Rugby Academy, which is one of the largest junior rugby programmes in Singapore with over 600 boys and girls from the ages of 4 to 17 (playing both contact and touch rugby). I am also a coach of the under 9s, under 11s contact and under 12s girls' touch and under 12s contact rugby squads for the Rugby Academy.

I have a keen interest in helping to develop youth sports at the club at all levels by both supporting the very successful academies that we already have and developing academies and youth programmes in other sports Sections. This is something I would like to continue if I am elected to this position.

On a final note – I mentioned in my supporting note last year that one specific project I had this last year was to work on the creation of the Club's first women's contact rugby team. I'm pleased to say that for the first time in the Club's history, on 20 March 2022, we fielded 3 women's contact rugby sides (under 14s, under 16s and under 18s) against Tanglin Rugby Club at Turf City, winning in two of those age groups.

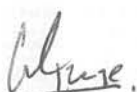
