- 1. To confirm the Minutes of the Annual General Meeting held on Saturday, 24 April 2021 and Minutes of the Special General Meeting held on Saturday, 30 October 2021.
- 2. To receive and, if approved, adopt the Committee's Report and Audited Accounts for the year ended 31 December 2021.
- 3. To elect a President, Deputy President, Chairman of Games Control Board, Finance Member and eight other Members of the Committee.
- 4. To elect Auditors and approve remuneration.
- 5. To vote on Resolution One in Annex 5 and such other Proposed Resolutions put forward in accordance with Rules 57(d) and 57(e), if any

To All Voting Members of the Singapore Cricket Club:

In compliance with Ministry of Health ("MOH") advisory, the General Committee made the decision to continue to hold the Annual General Meeting (the "AGM") via electronic means.

At 6.00pm, the virtual AGM will re-commence to deal with and complete the rest of the items on the agenda.
- (c) Prior to the virtual AGM on 09 April 2022, a member may submit queries or raise any matters to the SCC by post or email to qna-agm2022@scc.org.sg Such queries or matters must be submitted to the SCC by Friday, 01 April 2022 and members who have submitted queries or raise any matters must be present at the virtual AGM on 09 April 2022 for his or her question to be answered. The General Committee will try to answer relevant questions submitted but due to time availability it cannot be guaranteed that all relevant questions will be answered.
- (d) **The voting of the resolution** and election of a new General Committee will be by electronic means via the third-party software, Convene, on Saturday, 09 April 2022 from 11:00am to 7:00pm and members who have difficulty in voting via electronic means will be permitted to come to the Club to

vote in person electronically or with assistance provided on Saturday, 09 April 2022 from 11:00am to 7:00pm. The details are attached in Annex 3.
