I have also captained the SCC Tankards (2nd team), I was then Club Captain for the Rugby Section for two years and went on to be Convenor of the Rugby Section for another 3 years. I have been the co-chair of the Singapore Cricket Club International Rugby Sevens for two years (2017 and 2018). I am also involved in managing the SCC Rugby Academy, which is one of the largest junior rugby programmes in Singapore with over 750 boys and girls from the ages of 4 to 17 (playing both contact and touch rugby). I am also a coach of the under 11s boys and under 14s girls' touch rugby squads for the Rugby Academy.

Wine Circle (WC) has grown almost 3X in membership, enhanced member experience AND is in a strong financial position: During my 3 full terms being elected as Convenor, with the dedicated support of the WC committee and the Club management, our membership has grown almost 3-fold from 154 to 425 (CAGR of 40%). The Circle has also in a strong financial position with reserves also increasing almost 3-fold from SGD 38K to 97K. This is despite conducting of highly subsidized member events/promotions each month.

The Wine Circle took the lead and proactively reached out to embassies of many wine producing countries. It partnered with Hungary, Czechia, Portugal, Italy, Spain, Argentina, Chile to organise events where their Ambassadors attended as Chief Guests – a unique accomplishment for SCC.

During 2023-24, we embarked on a mission to enhance wine knowledge & conducted two cohorts of WSET* Level 1 course at the club premises. 34 SCC members and 5 SCC staff got certified, a unique accomplishment amongst all clubs.

I personally devoted considerable time & effort in my own Learning and Development to rise to the confidence reposed by our members & acquired the following certifications:

WSET Level 3 in Wines

WSET Level 2 in Spirits

WSET Level 1 in Sake

WSQ Certification (accredited by SG Government agency) in Coffee

I have been inducted as a Wine trainer by SHATEC (Singapore Hotel Association's Hospitality & Tourism school) & another wine academy.

My vision for SCC and how I can contribute to SCC: I view a GC role as a responsibility to each fellow member supplemented by the fulfilment of my desire to contribute back to the club. I believe that even while keeping our primary focus on sports, we can widen the member engagement & organise interactions with global and local thought leaders, futurists, and other eminent personalities, the like. This shall increase engagement of existing members & enhance the appeal to prospective members by supplementing the excellent package the club already offers. Given my corporate background & performing senior global P&L roles, just like as we have managed to accomplish with the Wine Circle, I feel I shall support my fellow committee members & club management in strategic initiatives to enhance club revenues without increasing burden on members. Leveraging my significant qualifications in beverages, and connect with industry, I can conduct skill enhancement programmes for the club staff and members and organise sponsorships of club events. Being a strong believer in constant improvement, I wish to be one of the catalysts to make SCC, the undisputed #1 social club in Singapore.

Leverage the deep knowledge & skills acquired from a professional background: After being employed for over 2 decades & assigned global responsibilities in banks & technology (Standard Chartered, American Express, ABN AMRO, Wipro), I now manage a boutique consultancy focussing on Strategy, Innovation & Human capital. I have been granted the 'Senior Practicing Management Consultant' their highest tier accreditation by the Singapore Business Advisors & Consultants Council. I have also acquired certification as an Executive Coach from Singapore Management University & focus on the CXO suite. I was selected to attend one of the most prestigious global leadership programmes – "Commonwealth Study Conferences – 2018" conducted under the patronage of Duke of Edinburgh which elicits participation of the top tier of Public Servants (including SG), Academics, NGOs and select businesspeople across the 56 countries of the Commonwealth.

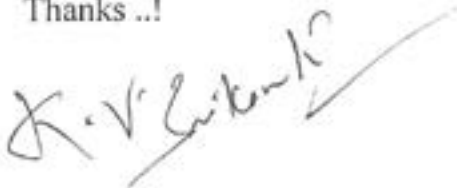

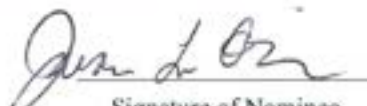

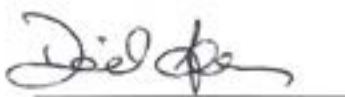
