# SPECIAL GENERAL MEETING – 23 SEPTEMBER 2025 NOTE TO MEMBERS: VOTING INSTRUCTIONS AND RESOLUTIONS

## **IMPORTANT VOTING INSTRUCTIONS**

 Please vote on <u>ALL</u> resolutions below. Your participation in <u>all</u> resolutions is essential for a comprehensive outcome.

#### 2. Understanding the Resolution Interactions

The three resolutions before you are interconnected. Please carefully consider the following explanations to understand how your votes will work together:

### 2.1 Resolution 1 and Resolution 2 Relationship:

- If Resolution 1 passes: This establishes a general policy to restrict the naming of facilities based on race, religion, or gender. Under this policy, the "Men's Bar" name would need to change, making the specific name change in Resolution 2 Part (A) automatic.
- If Resolution 1 fails: Resolution 2 Part (A) nonetheless provides a mechanism for determining whether members want to change the "Men's Bar" name specifically.

# 2.2 Conditional Voting Logic:

• Resolution 2 Part (B) only applies if either Resolution 1 passes OR Resolution 2 Part (A) passes

#### 3. Voting Scenarios Guide:

# 3.1 If you want NO change to the "Men's Bar" name:

- Vote NO to Resolution 1
- Vote NO to Resolution 2 Part (A)
- Resolution 2 Part (B) becomes irrelevant but you are still required to vote for your preferred replacement name.
- Vote on Resolution 3 based on your preference

# 3.2 If you support the restriction to be placed on the general naming policy and with it the change to the "Men's Bar" name:

- Vote YES to Resolution 1
- Vote on Resolution 2 Part (A) as desired (note: this becomes less relevant if Resolution 1 passes)
- Vote on Resolution 2 Part (B) for your preferred replacement name
- Vote on Resolution 3 based on your preference

# 3.3 If you oppose the restriction to be placed on the general naming policy but still want a change to the "Men's Bar" name:

- Vote NO to Resolution 1
- Vote YES to Resolution 2 Part (A)
- Vote on Resolution 2 Part (B) for your preferred replacement name
- Vote on Resolution 3 based on your preference

#### THE RESOLUTIONS FOR VOTING

#### A. RESOLUTION 1

#### **General Naming Policy**

"No facility at the SCC shall be or can be named on the grounds of race, religion or gender."

**Note:** This resolution establishes a comprehensive policy for current and future facility naming. It includes appropriate exceptions for facilities that must be labeled for legal or functional purposes (such as changing rooms) and temporary installations for cultural celebrations (such as Chinese New Year, Deepavali, and Hari Raya events).

#### Your Vote:

- [ ] YES I support establishing this general naming policy
- [ ] NO I do not support this general naming policy

#### **B. RESOLUTION 2**

Specific Name Change for "Men's Bar"

#### Part (A)

"The name 'Men's Bar' be immediately replaced with a new and neutral name to be chosen by members, from the choices below."

**Note:** This resolution specifically addresses the "Men's Bar" name change. If Resolution 1 passes, this resolution's practical effect is limited as the general policy would already require the name change.

#### Your Vote:

- [ ] YES I support changing the "Men's Bar" name to a neutral alternative
- [ ] NO I do not support changing the "Men's Bar" name

### Part (B)

"If Resolution 2 Part (A) passes, or if Resolution 1 passes, which name do you prefer for the renamed facility?"

Note: This selection will only be implemented if either Resolution 1 passes OR Resolution 2 Part (A) passes.

#### Your Vote:

- [ ] 1852 I prefer this name for the renamed facility
- [ ] Captain's Bar I prefer this name for the renamed facility

#### C. RESOLUTION 3

### **Historical Acknowledgment Plaque**

"The General Committee shall create and prominently and separately display a plaque acknowledging the historical origins of the Men's Bar at or near the entrance to the newly named Room."

#### Your Vote:

- [ ] YES I support installing a historical acknowledgment plaque
- [ ] NO I do not support installing a historical acknowledgment plaque

- 1. Vote on ALL resolutions Each resolution addresses a different aspect of the naming issue.
- 2. **Consider the interactions** Your combination of votes determines the overall outcome.
