Mandatory GIRO Payment Arrangement

As part of our continual efforts to provide members with a high standard of service and efficient account management, all members are required to be enrolled in the Club's GIRO payment scheme for the settlement of their monthly statement of accounts. Members who have not yet enrolled for GIRO payment scheme are required to submit their completed GIRO application form promptly.

Notes on GIRO

1. Your GIRO arrangement will become effective only when your monthly statement of account indicates that **"The amount will be deducted through GIRO"**.
2. Please state clearly your membership number on the GIRO application form.
3. The Bank will deduct the amount shown on your monthly statement of account. Deductions will be made on the **21st of each month**. If the 21st falls on a weekend or public holiday, the deduction will be made on the preceding business day.
4. If you wish to terminate your GIRO arrangement, you must provide written notice to both your Bank and the Club.
5. Some banks may levy administrative charges for unsuccessful deductions due to insufficient funds or any other reasons.
6. In the event of an unsuccessful deduction, payment must be made by Cash, NETS, PayNow or Internet Banking before the due date shown on your statement of account. Late payment charges will be imposed on outstanding accounts.
7. You may arrange for another party to pay for the monthly statement of account via GIRO using his/her bank account. However, your membership number must be stated on the GIRO application form.
8. Banks typically takes one month to process GIRO applications. During this period, members should continue to settle their accounts using the existing payment methods.
