    - (2) Copy of Certificate of Incorporation from Singapore Registrar of Companies (ACRA);
    - (3) Copy (front and back) of NRIC or passport of nominee(s), spouse and children (if applicable);
    - (4) Copy (front and back) of Employment Pass and/or documents evidencing nominee(s)’s residency status in Singapore (if applicable);
    - (5) One digital passport-size colour photo taken against a plain white background, without head covering or shadows, and facing forward, is required for the nominee(s), spouse and children (if applicable);
    - (6) Marriage certificate (if applicable);
    - (7) Personal Data Protection Act (PDPA) Member’s Consent Form; and
    - (8) Completed GIRO Application Form (as attached to this application form).
- \*\*This refundable deposit is compulsory and for each member's credit facility. Members will be billed on a monthly basis via a statement of account. The deposit will be refunded upon account cessation.*
- Payments submitted with this application and accepted by the Club shall not constitute an approval of the membership application. The payments shall be refunded to the applicant in the event that the application is rejected.
  - Please note that if any of the foregoing documents including the necessary payments is not furnished together with this application form, or if this application form is incomplete, your application herein will not be processed by the Club at all.

**(B) TERMS & CONDITIONS  
Corporate (Transferable) Membership**

We agree to the following terms and conditions (without derogation to such Rules of the Clubs and its by Laws which may be in force from time to time (“the Rules”):-

1. The General Committee of the Singapore Cricket Club (the “Committee”) has absolute discretion to:-
  - (a) approve or reject any application for membership and nominee(s) without assigning any reasons whatsoever. In the event an application is rejected, then all payments submitted with this application shall be refunded to us (without any interest or compensation) by ordinary post;
  - (b) at any time restrict the number of members of any or all categories of membership and/or close the membership of the Club from time to time; and
  - (c) conduct subsequent launches for new memberships in such manner and on such terms as the Committee deems fit.
2. The membership fee is subject to prevailing government taxes.
3. You shall be entitled to nominate one or more (subject to their entitlement) person/s within our corporation who shall, on being found to be eligible to be a member, be entitled to enjoy the full privileges of an Ordinary Member, including the right to vote at all meetings. Each nominee may include his family – his/her spouse and unmarried children who are aged upto 26 years old.
4. You understand that whenever a vacancy occurs in our nominee(s), we shall nominate in writing the person(s) to fill such vacancy within two months of such occurrence. Any failure to make such written nomination by the time limited therefore shall render us liable for payment of subscriptions payable under the Rules regardless of whether its nominee(s) is rejected by the Committee as being ineligible to be a member.
5. Upon receiving written confirmation from the Committee that your application for Corporate (Transferable) Membership has been accepted, you understand that you shall become candidates awaiting election, subject to your payment of all monies due to the Club in accordance with the Rules of the Club (the “Rules”). You also undertake and agree to abide by and be bound by the Rules and any such regulations or bye-laws as may be prescribed by the Committee and/or the Management from time to time and any other such amendments thereto, as well as all resolutions passed at the General Meetings of the Club.
6. You understand that if you become candidates awaiting election, you will essentially be provisional members of the Club, whereby such provisional membership will be for a period of six (6) months, unless otherwise abridged or varied or extended by the Committee in writing in the exercise of its sole discretion. You are aware and agree that the Committee and/or the Management will, during this period of provisional membership,

conduct the necessary due diligence and/or background checks on you, which may include but shall not be limited to checking on your credit standing, business ownership and litigation history. You may however during the time that you are a provisional member proceed to nominate your nominee(s).

7. You are also aware that during the period of such provisional membership, your nominee(s) will be entitled to the privileges as set out at Rule 23(c). You are further aware that you/your nominee need to pay monthly subscriptions from the date the nominee is accepted by the Committee or within one month after the date on which your application for membership is accepted, spend a minimum amount on food and beverage every month / quarter, and maintain a deposit with the Club pursuant to Rule 49.
8. You acknowledge that should we fail to secure the votes of six (6) members of the Committee within six (6) months after becoming candidates awaiting election, or such longer period as the Committee may in its sole discretion determine on a case by case basis, the acceptance of this application for membership shall be deemed to have lapsed.
9. You also acknowledge that monies paid to the Club will only be refunded to you if your application for membership is rejected or withdrawn or deemed to have lapsed under the Rules, and that the Club is entitled to deduct all administrative fees and all debts (if any) due to the Club and incurred by you (including your family and guests, where applicable) from the date of our application till the rejection or withdrawal or lapse of our application, as the case may be.
10. You acknowledge and agree that should you default on any payments to the Club, be it in entrance fee, monthly subscriptions or any other monies owing to the Club, the Club shall be entitled to suspend your nominee(s) membership privileges and thereafter terminate your membership. If no payment is forthcoming, the Club reserves the right to seek legal redress for all outstanding debts owing to the Club eventhough it may be incurred by your nominee(s) including legal costs incurred in connection thereto, whether before or after our membership is terminated.
11. In accordance with the Rules, you are also aware that your nominee(s) shall cease to be a member of the Club and their names shall be removed from the Club's list of members in any of the following events where the member:-
  - (a) has resigned or died;
  - (b) has been adjudicated bankrupt, as from the date of such adjudication;
  - (c) makes a composition or arrangement with his creditors under the provisions of any Ordinance or Act;
  - (d) has been expelled from the Club;
  - (e) has been convicted in a Court of Law of competent jurisdiction of any offence which in the opinion of the Committee would, if permitted to remain as a member, place the Club in disrepute or embarrass the Club in any way;
  - (f) flees the country to escape criminal proceedings; or
  - (g) has become an enemy alien.
12. There will be an administrative fee imposed for any change of nominee(s), such sum as the Committee in its sole discretion shall determine from time to time.
13. You may (subject to a transfer fee as determined by the Committee from time to time and in accordance with the Rules) transfer your membership to any corporation that the Committee may in its sole discretion approve in writing.
14. Nothing herein shall restrict the discretion of the Committee to reject the application to transfer a Corporate Membership (Transferable) if the transferee (Corporation) is not acceptable to the Committee or it is deemed by the Committee that the transfer, if effected, may be seen to be an attempt to accord an undue preference to the creditors of the Corporate Member (Transferable) under Section 329 of the Companies Act, Chapter 50, or such other legislation dealing with such matters.
15. You hereby confirm that you shall be liable for the payment of all subscriptions, fees and monies due on the accounts of your nominees with the Club.

Also, in the event that any of the information provided in this application is found to be untrue and/or incorrect, or should any bankruptcy or legal proceedings be commenced or threatened against us following the submission of this application herein, we acknowledge and accept that the Club may reject our application for membership herein and/or terminate our membership (as the case may be) without assigning any reasons whatsoever.

We also agree that we shall be bound by the Club's Rules and Bye-Laws and other regulations currently in force, and those that may be added or amended by the Club from time to time as it may consider appropriate.

- 4 If you wish to terminate the GIRO permanently, please write to your bank to effect the termination and extend a copy of your letter to the club for reference.
- 5 Some banks levy a surcharge for unsuccessful deduction for reasons such as insufficient balance in bank account.
- 6 For unsuccessful deduction, you would then have to pay the amount shown on your statement by cash/cheque/Nets/Internet banking before the due date of payment for that statement. Otherwise, late fine shall be imposed for payments after the due date.
